6. SPORTS ELIGIBILITY: The meritorious sportspersons will be considered for appointment based on the following criteria:



i) Sportsmen who have represented a State or the country in the National or International competition;
 or Medal winners in Junior National Championships; or Medal winners in Khelo India Youth Games

(age category above 18 years); or Khelo India Winter Games; or Khelo India Para Games; or Medal winners in Khelo India University Games; or Medal winners in School Games Federation of India (SGFI) in any of the games/sports mentioned in Para 5.

For Chess: Grand Master (GM) Title, International Master (IM) Title, Chess Olympiad. IM/GM title should be in Open Category like Woman Grandmaster (WGM) etc. While National Open Chess Championship is treated as National Championships, the medal winning performance in National Team Chess Championship will also be considered.

- ii) Sportsmen who have represented their University in the Inter-University Tournaments conducted by the Inter-University Sports Boards in any of the sports/games specified in Para 5.
- iii) Sportsmen who have represented the State School Teams in the National Sports/games for schools conducted by the All-India School Games Federation in any of the games/sports mentioned in Para 5.
- iv) No such appointments can be made unless the candidate is, in all respects, eligible for appointment to the post applied for, and in particular, with regard to age, educational or experience qualifications prescribed under the Recruitment Rules applicable to the post, except to the extent to which relaxations thereof have been permitted in respect of class/category of persons to which the applicant belongs.

Note: The order of preference given in Para VI of Consolidated OM No. DOPT-1720781414772 dated 04.03.2024 will be followed in the selection process. Further, the candidates will be evaluated based on the year of participation in recognized tournaments/events held between the calendar years 2020 and 15.03.2025. Relevant details should be provided as per Annexure-A.

8. HOW TO APPLY:

Applications must be submitted only by **online mode** which can be accessed from the following URL: <u>www.incometaxhyderabad.gov.in</u>. Last date to submit the application online is on or before 05.04.2025. (5th April,2025)

Note: Each candidate shall submit only one application form. Submitting more than one form may render one's candidature invalid.

- 9. The applicant shall upload attested copies of the following certificates:
 - Matriculation/SSC or equivalent certificate for proof of age.
 - (ii) Certificates of Educational qualifications. (As per the requirements of the post)
 - (iii) Sports/games certificates as mentioned in Paragraph 7 above.
 - (iv) SC/ST/OBC community certificate.
 - (v) Valid Proof of ID (Aadhar Card, Driving License, Passport, PAN Card or Voter ID)

The candidate must be in possession of the requisite qualification for the post concerned as on the date of his/her application.

- 10. Candidates who are already employed in Central Government or State Government or PSU should submit the NOC from the present employer which should be uploaded along with the online Application Form.
- 11. The selected candidates will be posted in Andhra Pradesh and Telangana Region only. The selected candidates will be on probation for 2 years or such period as per the extant instructions of the Government of India.
- Services of the selected candidates as far as participation in sporting activities and leave management etc. shall strictly be subject to fulfilment of the conditions as enumerated in the DOPT's O.M. No. 6/1/85-Estt.(Pay-I) dated 16th July, 1985.
- 13. Application duly filled and completed in all respect, shall be submitted online on or before 05.04.2025. The application link in the website will be functional till 23:59 Midnight of the stipulated date.
- 14. Applications submitted manually and also applications submitted online with soft copies of invalid documents or illegible scanned documents, will be rejected and no correspondence in the matter will be made with the applicant. Shortlisted candidates will be called for Document Verification. The date and venue for Document Verification will be intimated to the shortlisted candidates in due course. Any Corrigendum with respect to this Notification will be published only on the official website: www.incometaxhyderabad.gov.in
- 15. Any form of canvassing by any candidate will render his/her candidature liable to be rejected summarily at any stage of recruitment process.
- 16. The Pr. Chief Commissioner of Income Tax, Andhra Pradesh and Telangana region, has the right to cancel the recruitment process at any stage without assigning any reason and the Pr. CCIT's decision on all matters related to sports recruitment will be final. If no eligible candidates are available for a given vacancy, the Pr. CCIT may reallocate the vacancies.



17. ADDITIONAL INSTRUCTIONS:

- a. Failure to comply with the instructions/conditions prescribed in the notification will result in the rejection of the application and no intimation will be served. No communication in this regard will be entertained.
- b. In respect of appointment for the post of Stenographer Grade-II, the selected candidates will be required to qualify the Skill test. For this purpose, the Dictation test will be for 10 minutes @ 80 w.p.m and Transcription will be 50 w.p.m. (English) and 65 w.p.m. (Hindi) only on Computers, in accordance with the provisions of the relevant Recruitment Rules.
- c. In respect of appointment as Tax Assistant, the selected candidates will be required to qualify the Data Entry Skill Test @ 8000 key depressions per hour, in accordance with the provisions of the relevant Recruitment Rules.
- d. The applicants are advised to visit <u>www.incometaxhvderabad.gov.in</u> from time-to-time for more details and information.
- e. In case of any discrepancy regarding the wordings in the advertisement, the English version of the advertisement will prevail over the version in other languages.
- The selected candidates should produce relevant original certificates at the time when they
 are called for document verification.
- g. Medical fitness of the candidates will be ascertained by the O/o Pr. CCIT, AP&TG Region, before their formal appointment.
- h. The candidate should be clear in all the Doping tests done by the World Anti-Doping Agency (WADA)/National Anti-Doping Agency (NADA) or any other relevant authorities. Additionally, the candidate should not have been disqualified from any tournament or banned by the respective sports federation due to disciplinary action. Furthermore, any ongoing investigation related to doping or the use of unfair means in any sporting event must be disclosed, and the candidate is required to furnish these details. The candidate should also declare all other relevant matters such as pending criminal cases, matters of disciplinary actions, matters of disqualification or ban etc. The Candidate should upload the signed copy of the self- declaration in the format given in Annexure B to this Notification.
- The appointment of the candidates will be subject to clearance received in this regard from the Police authorities of their current place of residence after verification.
- No Travelling allowance will be paid to the selected candidates for their journey to Hyderabad for joining the Department after selection.
- k. Any dispute in regard to this recruitment will be subjected to courts/tribunals having jurisdiction over the Hyderabad.
- If at any stage during or after the recruitment process, the candidate is found to have furnished any wrong information, statement or declaration or falsified/misrepresented any facts, his/her candidature/appointment will be liable for cancellation.
